Singapore's gross domestic product grew 3.6% in 2017 and the Singapore government expects growth to be 2.5% to 3.0% in 2018. The U.S. position as Singapore's third largest source of imports was unchanged and China and Malaysia retained their first and second position respectively, followed by Taiwan,

Japan, South Korea, Indonesia, Germany, Saudi Arabia and Switzerland.
