In the United States income tax system, adjusted gross income (AGI) is an individual's total gross income minus specific deductions. Taxable income is adjusted gross income minus allowances for personal exemptions and itemized deductions. For most individual tax purposes, AGI is more relevant than gross income.

Modified AGI limit for certain married individuals. If you are married and your spouse is covered by a retirement plan at work and you aren't, and you live with your spouse or file a joint return, your deduction is phased out if your modified AGI is more than \$186,000 (up from \$184,000 for 2016) but less than \$196,000 (up from \$194,000 for 2016).
